

About Delhi



Delhi is a city that bridges two different worlds. Old Delhi, once the capital of Islamic India, is a labyrinth of narrow lanes lined with crumbling *havelis* and formidable mosques. In contrast, the imperial city of New Delhi created by the British Raj is composed of spacious, tree-lined avenues and imposing government buildings. Delhi has been the seat of power for several rulers and many empires for about a millennium. Many a times the city was built, destroyed and then rebuilt here.

New Delhi, the capital of India, is a bustling metropolis that has an amazing mix of modernisation and carefully preserved antiquity. Delhi has the most vibrant history having been the "capital of seven empires" with over 60,000 recognized monuments built over several millennia. The Victorian architecture of New Delhi now intermingles with the city's high rise buildings. Concrete flyovers built to ease the growing traffic are interspersed with well laid gardens, Mughal tombs, forts, fascinating museums and art galleries, architectural wonders, a vivacious performing-arts scene, fabulous eating places and bustling markets.

Old Delhi is a labyrinth of narrow lanes lined with breathtaking architectural and historic gems. The captivating stories that the many *havelis*, tombs and mosques tell tales of a rich historical,





cultural and political history. Chandni Chowk with its famous, historic shops and alleys and Connaught Place which is composed of spacious, tree-lined avenues and imposing government buildings are both representatives of a city which is a perfect blend of the past and the future.

Qutub Minar, a 234 feet high minaret and the highest individual tower in the world, Lal Qila (Red Fort), one of a kind red stone wonder completed under the watch of Shahjahan—the Mughal King (Incubator of the famous Taj Mahal)—in 1648, Jama Masjid, the largest mosque in India, Rashtrapati Bhavan one of the largest residential houses of any Head of the State in the world in terms of its size, vastness and its magnificence, India Gate, a breathtakingly beautiful war memorial are important tourist destinations. Other places of interest are the memorials of Safdarjung Tomb, Akshardham Temple, Jantar Mantar, Gurudwara Bangla Sahib and Lotus Temple.

From the by-lanes of the walled city to the swanky hotels and restaurants, Delhi gives you the option of choosing from the wide variety of cuisines, which is a mixture of regional and international food. All these varieties are readily available in every part of Delhi. It is a city that has a story waiting to be discovered in every nook and corner, which will mesmerize you with its rich heritage and culture.

No trip to Delhi is complete without visiting the Taj Mahal at Agra (about 4 hours by car from Delhi).

Clothing

Even though November is not the peak winter season in Delhi, it is advisable to carry light woolen clothes.



Language

Hindi is recognized as the official language of the country. English is recognized as the language of National, Political and Commercial communication. English in Delhi, is a language with which nearly all the inhabitants of the city are familiar. It is a popular means of communication, particularly among the youngsters. Tourists in the city have absolutely no problem in communicating with the local people as almost everyone can interact like a travel guide.

Currency

The Rupee is the official currency of India. The Indian Rupee may be abbreviated in any of the following formats INR, Rs. or ₹.

INR are available as paper notes in denominations of 10, 20, 50, 100, 500 and 1000. INR are also available as coins in denominations of 1, 2, 5 and 10.

Changing money in India is very simple. Upon arrival in India, foreign currencies can be converted into INR at foreign exchange counters at airports. These outlets are open 24 hours a day, 7 days a week. You can also find foreign exchange desks at star-rated hotels. Traveler's cheques may not be accepted at all banks or hotels. There are automatic teller machines (ATMs) which dispense cash throughout the city. Although these machines are linked to a specific local bank, most major credit and debit cards, both domestic and international, should be accepted. Kindly note that certain credit cards may not be accepted.

Taxis



Taxis are on call round-the-clock in Delhi. Air-conditioned (AC) radio taxis may be called by dialing +91 11 43434343 or +91 11 44224422. These taxis have a flat charge per kilometer travelled, and are available at both the international and domestic terminals of the airport. In addition, there are prepaid taxi counters at the airport for travelling to any part of the city. We advise that

hiring private cars and unlicensed taxis must be done with caution and is not recommended for delegates.

Hotel front desks will normally be able to arrange reliable transport by taxi but they will require 15-30 minutes' notice in order to do so. Taxis are willing to wait for you during your intermediate stops at reduced charges. It is simplest to inform the front desk the places you wish to visit, the total time you wish to spend and the number of persons travelling. They would then be able to book the taxi for you at a fixed rate.


Local Time

Indian Standard Time (IST) is 5 hours 30 mins ahead of GMT and 10 hours 30 mins ahead of Eastern Standard Time (EST).

All public areas are non-smoking except for specifically labeled smoking areas.

How to reach Shangri-La's Eros Hotel from Indira Gandhi International Airport



Shangri-La's Eros Hotel is situated in Central Delhi, which is 30 km. from Indira Gandhi International Airport and 28 km. from the domestic airport.





If you are flying in:

From the airport (both domestic and international) you can take a private taxi (Meru, Mega Cabs, Easy Cabs) to reach the hotel, which will charge you between INR 1,000 to INR 1,500 (approx. 15 to 20 Euros), or you can take a prepaid taxi from a booth situated outside the airports. A prepaid taxi will be cheaper than a private taxi. Ideally, however, opt for your hotel's airport transfer – while more expensive, it will be most convenient and very safe.

Visa Information

ALL FOREIGN ATTENDEES ARE REQUIRED TO APPLY FOR A CONFERENCE VISA

Type of Visa: Conference Visa

Period: For the duration of the conference or seminar

Foreign attendees should ensure that they are in possession of a valid Indian visa before they begin their travels to India.

The Consular Passport and Visa (CPV) Division of the Ministry of External Affairs is responsible for issuance of Indian visas to foreign attendees. This facility is granted through various Indian missions abroad.

Visa fees are non-refundable and subject to change without notice. The High Commission reserves the right to grant and decide the type and duration of visa, irrespective of the fees tendered at the time of application. Granting a visa does not confer right of entry to India and is subject to the discretion of the Immigration Authorities.

Visa Application Form:

The visa application form is available at the Indian Embassy office in your country.

Procedure for Obtaining Visa:

Visas can be applied for in person or by post at the High Commission of India based in your country.

The attendees can also fill the online visa application by visiting the following website: www.indianvisaonline.gov.in/visa/ and going to their nearest embassy with printouts of the online filled application and required travel documents.

Requirements for Visa:

Generally the following documents are required for obtaining an Indian visa. However, requirements may vary from country to country.

- Original passport valid for at least 6 months
- Duly completed application form
- Visa fee
- Two passport size photographs
- Passport
- Supporting documents, where necessary
- An invitation letter, which will be sent to you by the Conference Manager after successful registration





- Approval letter from the Ministry of External Affairs
- Approval letter from the Ministry of Home Affairs

Eligibility

- International travellers whose sole objective of visiting India is recreation, sightseeing, casual visit to meet friends or relatives, short duration medical treatment or casual business visit.
- Passport should have at least six months validity from the date of arrival in India. The passport should have at least two blank pages for stamping by the Immigration Officer.
- International travellers should have return tickets or onward journey tickets, with sufficient money to spend during his/her stay in India.
- International travellers holding Pakistani passports or being of Pakistani origin may please apply for regular visa at Indian Mission.
- Not available to Diplomatic/Official Passport Holders.
- Not available to individuals endorsed on parents'/spouse's passport i.e., each individual should have a separate passport. e-Tourist visa will be granted only against valid passports.
- Not available to International Travel Document Holders.

Visa on Arrival

Citizens of Japan can apply for visa on arrival in Bengaluru, Chennai, Delhi, Hyderabad, Kolkata or Mumbai since 1 March 2016.

CUSTOMS GUIDE FOR TRAVELLERS

Every passenger entering India has to pass through a Customs check. The passenger has to declare the contents of his/her baggage in the prescribed Indian Customs Declaration Form at the airports. The passenger has the option of seeking clearance through the Green Channel or through the Red Channel, subject to the nature of goods being carried.

Green and Red Channels

For the purpose of Customs clearance of arriving passengers, a two-channel system has been adopted:

- (i) Green Channel for passengers not having any dutiable goods.
- (ii) Red Channel for passengers having dutiable goods.

However, Green channel passengers must deposit the Customs portion of the disembarkation card to the Customs official at the exit gate before leaving the terminal. Declaration of foreign exchange/currency has to be made before the custom officers in the following cases:

- (a) Where the value of foreign currency notes exceed USD 5,000 or equivalent.
- (b) Where the aggregate value of foreign exchange including currency exceeds USD 10,000 or equivalent.
 - Passengers walking through the Green Channel with dutiable/prohibited goods are liable to prosecution/ penalty and confiscation of goods.
 - Trafficking of Narcotics and Psychotropic substances is a serious offence and is punishable with imprisonment.

Duty Free Allowances and Entitlements for Indian Residents and Foreigners Residing in India

A resident is defined as a person holding a valid passport issued under the Passports Act, 1967 and normally residing in India.

- (a) Nepal, Bhutan, Myanmar or China.
- (b) Pakistan by land route

Note:

- 1. The free allowance shall not be pooled with the free allowance of any other passenger.
- 2. The free allowance is not applicable to the following goods:
 - a. Fire arms
 - b. Cartridges of firearms exceeding 50
 - c. Cigarettes exceeding 100 or cigars exceeding 25 or tobacco exceeding 125 gm.
 - d. Alcoholic liquor or wine in excess of 2 litres





- e. Gold or silver any form, other than ornaments
- f. Flat Panel (LCD/LED/Plasma) television
- 3. One laptop computer (notebook computer) over and above the said free allowances mentioned above is also allowed duty free if imported by any passenger of the age of 18 years and above.
- The goods over and above the free allowances shall be chargeable to customs duty @ 4. 35% + an education cess of 3% i.e., to say the effective rate is 36.05%.
- Alcoholic drinks and tobacco products imported in excess of free allowance are 5. chargeable to custom duty at the rates applicable to their commercial imports as per the Customs Tariff Act, 1975.
- 6. Passengers normally resident of India who are returning from a visit abroad may carry Indian currency up to Rs. 25,000.
- 7. In case the value of any one item exceeds the duty free allowance, the duty shall be calculated only on the value in excess of free allowance.

Duty Free Allowances and Entitlements for Tourists and Definition of Tourist

A tourist is a passenger

- who is not normally a resident in India;
- who enters India for a stay of not more than six months in the course of any twelve months period for legitimate non-immigrant purposes, such as : touring, recreation, sports, health, family reasons, study, religious pilgrimage, or business.

A tourist arriving in India shall be allowed duty free clearance of articles in his bona fide baggage to the extent as mentioned below:
