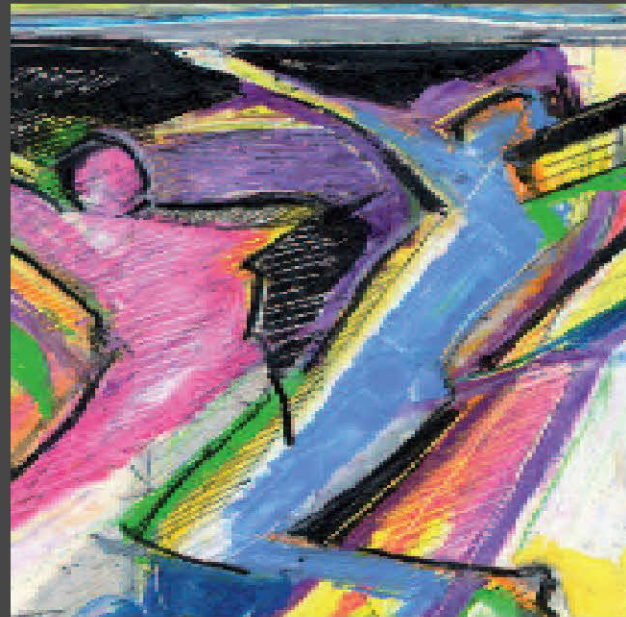

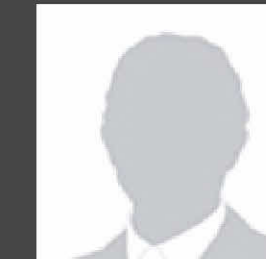

How we operate

1 • Preliminary **market research** with **analysis of the competition and the characteristics of the product**, with the aim of ascertaining whether the client is ready to **tackle the market in question**, and **whether the market conditions are favourable**

2 • If the **outcome** of the research is **positive**, Italservice offers its client **several types of solution, in relation to the objectives** that the client company has set itself, and depending on the **allocated budget**.

The proposed solutions

1. Selection

of a commercial counterpart who acts as agent or distributor for the whole territory to be entered into

2. Creation of a sales office
