ECIJA and Grandall sign the biggest strategic agreement between a Spanish and a Chinese firm, turning out to be 3,500 lawyers and 54 offices in Iberia, Latin America and Asia.

**The Spanish firm ECIJA and the Chinese giant Grandall** announce the subscription in Madrid, Spain, of one of the mayor strategic agreements between a Spanish and a Chinese firm. # Australia's CGT main residence exemption removed for foreign residents

#### Australia's Current CGT main residence exemption

Under the current law, all taxpayers (residents and foreign residents) are entitled to the capital gains tax ('CGT') main resident exemption, where their property is, or has been their family home or main residence for a period of their ownership. This provision means that any capital gains made in relation to a qualifying main residence are currently exempt from CGT. This is a very generous concession as it allows taxpayers to claim the tax exemption even if they no longer live in the property provided they do not have another property as their main residence and provided they do not use the property for income producing purposes (i.e. rental income). However, if the property is being used for income producing purposes the exemption is capped at six years. This allows individuals who are no longer residents under the "absence rule" to claim this exemption either indefinitely or up to six years depending on whether the property is
