Featured Client - Prime Meat ROKKO

The client is a Japanese Steakhouse chain Prime Meat Rokko which had secured and built out a space in midtown New York City for its U.S. expansion, investing hundreds of thousands of dollars. It had hired an attorney based in NY who presented two E-2 cases on its behalf, in an extremely unprofessional manner, inconsistent and contradictory, with incorrect and invented information, and both applicants were rejected in a 2-minute interview where the consular official told them "Get a lawyer who knows what they are doing and present the case correctly."

The client was then referred to SMA, who re-engineered the cases and submitted them within a month's time. Due to bad luck, the interviews were canceled due to the Covid pandemic, and as the Client waited for its interviews at the US Embassy in Tokyo, their expenses and costs continued to accumulate, with an empty restaurant which they were not able to open since they were not there to take the final steps in getting it ready and to hire and train the new staff. Money was going to run out eventually. Finally, a few months ago, they both had their interviews and were both approved, despite the track record established by the previous attorney, and they were able to travel to the US and get their business going. Steve Maggi was their guest of honor, as they were able to celebrate together.
