



The future of L-1A and L-1B visas

In mid-March the U.S. government closed the US embassies and consulates and stopped issuing visas. To make it more complicated for multinational companies, the Presidential Proclamation issued June 22nd barred the issuance of new L-1A and L-1B visas until the end of the year, leaving thousands of people with approved petitions out in the cold, and US companies without their key executives, managers and specialized knowledge employees. Recently, a window opened to allow these visas to be issued which met the National Interest Exception, a great work-around which, if properly and exhaustively presented, can lead to the issuance of L-1A and L-1B visas.
