### UK to be the first EU member to adopt plain packaging for cigarettes: what will this mean for brand owners?

The UK will become the first member state of the EU to require plain or standardised packaging for cigarettes and hand-rolling tobacco after the House of Lords rubber stamped legislation (The Standardised Packaging of Tobacco Products Regulations 2015) on 17 March 2015 without a vote. MPs had overwhelmingly (367 in favour, 113 against) approved the move the previous week, notwithstanding strong opposition from the tobacco industry. 
